PLEASE TAKE NOTICE that on September 29, 2020, at 10:00 a.m., or as soon thereafter as counsel may be heard, Labaton Sucharow LLP, Court-appointed Lead Counsel for Lead Plaintiff the Public Employees' Retirement System of Mississippi and the Settlement Class, will move this Court, before the Honorable Douglas E. Arpert, for an Order, on behalf of Plaintiff's Counsel, pursuant to Rule 23(e) and 54(d) of the Federal Rules of Civil Procedure: (i) awarding attorneys' fees of 25% of the Settlement Amount; (ii) awarding payment of litigation expenses; and (iii) approving Lead Plaintiff's request for reimbursement related to its representation of the Settlement Class, pursuant to the Private Securities Litigation Reform Act of 1995.
